

Education



To instruct, train, and inform government financial managers in the fields of accounting, auditing, budgeting, and financial management. This continuing education process provides for the professional development of government financial managers so that they may better serve the public.

The Greater Lansing Chapters had established three top priorities for the 2013-2014 year.


1. Increase chapter membership. The chapter had 100 members at June 30, 2013. Membership was increased and the chapter had 109 members at June 30, 2014.
2. Increase the chapter fund balance. The chapter fund balance was \$4,535 at June 30, 2013. The fund balance was increased and the chapter fund balance was \$7,423 at June 30, 2014.
3. Redesign the chapter website. The chapter launched its new website in January 2014.



Our Chapter's Future



The Greater Lansing Chapter will continue to provide quality education to the government accountability community at a reasonable cost. The Chapter saw a decline in attendance at its professional development trainings the last couple of years but believes it can increase attendance with relevant topics and reasonable costs.

The Greater Lansing Chapter has struggled with recruiting new chapter members. Seventy percent of the membership is employed by the State of Michigan. The State, as with many governments, has been forced to downsize its workforce. Hiring freezes have been in effect for several years and reaching out to new hires is limited. Membership recruitment will continue to be a challenge in the coming year. The chapter continues its outreach efforts to increase its membership with efforts directed to early career individuals.

The Greater Lansing Chapter is fortunate that it has been able to fill all positions on the Chapter's Executive Committee. The Chapter hopes to continue the trend and attract qualified individuals to the committee.

About Citizen Centric Reporting

AGA's Citizen-Centric Government Reporting Initiative is intended to foster innovative means of communication between governments and their citizenry. AGA believes that government financial information should be provided to citizens in forms that are clear and understandable, updated regularly and often, delivered to all, easy to locate, honest in breadth and technically accurate in detail. In fact, as the owners of government, citizens have a right to this information.

AGA's Citizen-Centric Reports detail government finances in a visually appealing, clear and understandable four-page document. The suggested format shows community information—such as population figures, regional characteristics and government goals for the community—on the first page, and the second page presents a performance report on key missions and service. The third page details cost and revenue information, and the fourth looks forward to the year ahead.
